POSITION GENERAL SUMMARY:

The Exceptional Student Education (ESE) Specialist acts as the liaison for the ESE Department and other FLVS departments as well as external district ESE departments, families, and students. The ESE Specialist keeps abreast of all changes in ESE state regulations, and provides training on ESE strategies in order to ensure student success and district compliance.

ESSENTIAL POSITION FUNCTIONS:

- Collaborate with Instructional, Leadership, and Professional Learning departments to heighten awareness regarding ESE teaching and learning strategies and state law
- Provide support to teachers, families, and students with the collaboration of a Literacy Coach to create a successful learning experience with FLVS
- Create and administer training for teachers on ESE strategies and state regulations, including not limited to mandatory and optional BITES sessions
- Create and distribute reference materials to Instructional and Guidance Counselors regarding the FLVS ESE student experience
- Stay current on DOE policy changes in regards to ESE state requirements and communicates to staff, as necessary
- Serve as a liaison between families/students and FLVS departments on how the FLVS experience can be improved
- Collaborate and liaison with Gifted programs, Career, and STEM
- Coordinate Customer ESE Awareness Open Houses
- Liaise with district ESE personnel
- Serve as liaison to the Literacy Team's ELL and ESE Task Force Initiative
- Provide professional development with the support and/or collaboration of the Literacy Team
- Participate in bi-weekly Literacy Team calls for DOE reading updates and collaborative planning
- Meet professional obligations through efficient work habits such as, meeting deadlines, honoring schedules, coordinating resources and meetings in an effective and timely manner, and demonstrate respect for others
- All work responsibilities are subject to having performance goals and/or targets established
