POSITION GENERAL SUMMARY:

The FLVS FT Assessment and Accountability Specialist implements testing administration functions and assists with materials to prepare students for high stakes tests. The Specialist works with an array of internal and external customers to schedule student testing and completion, as well as extensive data tracking and analysis.

ESSENTIAL POSITION FUNCTIONS:

- Assist in the coordination of Florida High Stakes Assessments for FLVS FT students
- Facilitate training for teachers, parents and staff
- Coordinate and schedule required assessments
- Obtain assessment results and enter into student records
- Act as liaison between FLVS FT and Florida school districts; and between FLVS FT and FLDOE
- Maintain communication with accountability team, staff and all stakeholders
- Assist with FL DOE communication and assessment-related uploads
- Record and analyzes data for all high-stakes testing
- Coordinate all internal and external communication specific to required assessment coordination
- Meets professional obligations through efficient work habits such as: meeting deadlines, honoring schedules, coordinating resources and meetings in an effective and timely manner, and demonstrates respect for others
- All work responsibilities are subject to having performance goals and/or targets established
