POSITION GENERAL SUMMARY:

The Support Representative, Field Operations performs various functions in support of the financial aspects of the business. The Support Representative, Field Operations generates and sends invoices to customers and for supporting the field by conducting customer usage audits on all products and as these audits relate to the use of external partner or vendor products and services as well as ensuring payment to the appropriate vendor or partner. The Support Representative, Field Operations continually tracks all data, using systems including the FLVS CRM.

ESSENTIAL POSITION FUNCTIONS:

- Generate and send invoices to customers
- Coordinate audits of customer usage against license to ensure proper settlement
- Work with external partners and/or vendors to produce usage audit reports
- Track all customer license usage end dates using the FLVS CRM or other systems
- Create and produce reports on customer usage end dates and provide information on upcoming renewals for customers
- Track and ensure renewal opportunities close before expiration
- Provide customer usage and renewal reports to leadership team
- Serve as secondary customer service representative assisting clients with various support needs and responding to or directing customer general inquiries
- Meet professional obligations through efficient work habits such as, meeting deadlines, honoring schedules, coordinating resources and meetings in an effective and timely manner, and demonstrate respect for others
