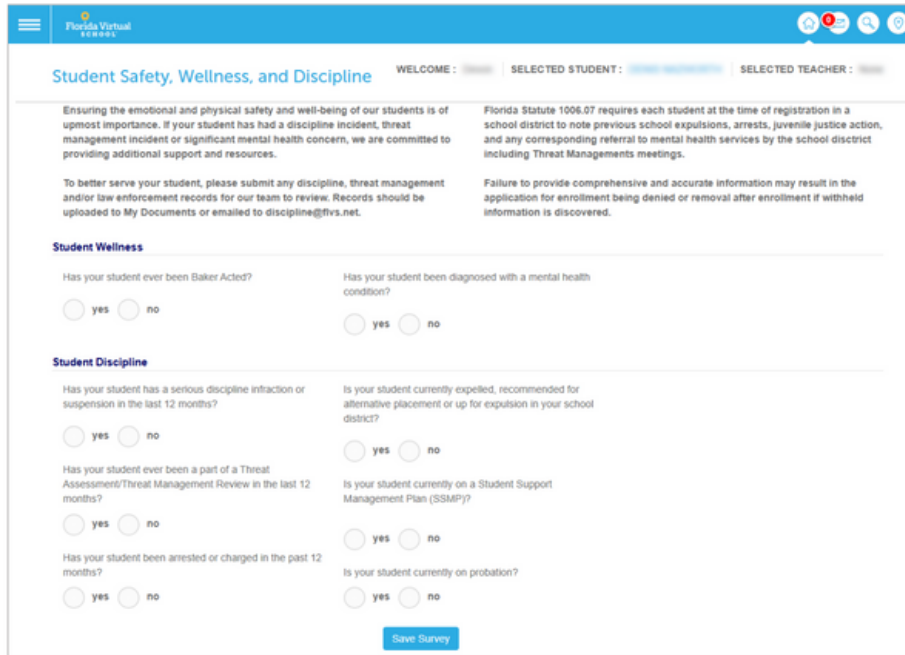




VSA: Student Safety, Wellness, & Discipline

For Flex enrollments only, students/guardians will be prompted to self-report recent discipline and matters relating to wellness to complete the enrollment process within VSA. This data will assist the Student Services team to provide additional support and enable FLVS to comply with a state mandate.



Student Safety, Wellness, and Discipline

Ensuring the emotional and physical safety and well-being of our students is of utmost importance. If your student has had a discipline incident, threat management incident or significant mental health concern, we are committed to providing additional support and resources.

To better serve your student, please submit any discipline, threat management and/or law enforcement records for our team to review. Records should be uploaded to My Documents or emailed to discipline@flvs.net.

Florida Statute 1006.07 requires each student at the time of registration in a school district to note previous school expulsions, arrests, juvenile justice action, and any corresponding referral to mental health services by the school district including Threat Managements meetings.

Failure to provide comprehensive and accurate information may result in the application for enrollment being denied or removal after enrollment if withheld information is discovered.

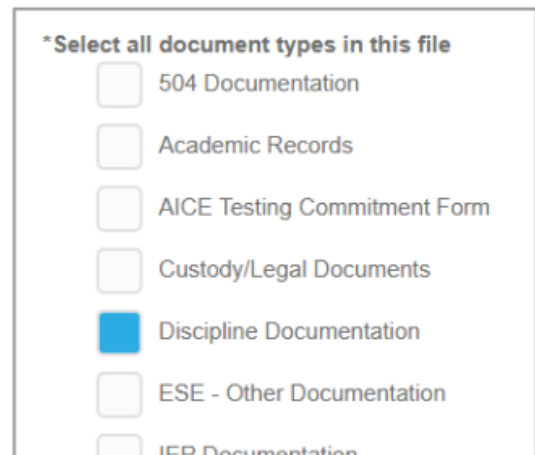
